**Rules:**

1. **Category 101 – 104 and 107 - 113**, piecing and quilting must be the work of the exhibitor.
2. **Category 105 - 106**, piecing must be the work of the exhibitor, quilting done by anyone other than the exhibitor will be considered Professionally Quilted. The top only will be judged.
3. **Old Quilts** need not be the work of the exhibitor and is not eligible for Best of Show.
4. Quilts entered in previous CEOS Quilt Shows may not be re-entered.
5. There is a limit of one entry per category per person.
6. Quilts may be submitted from July 1-3 at the WVU Extension Office during regular business hours (CLOSED on July 4th) or on **Monday July 7, from 5:00 to 8:00 pm or Tuesday July 8, from 8:00 am to 11:00 am** at Beaver Cottage in Nicholas County Veterans Memorial Park.
7. Labels are provided at check-in and will be attached to the bottom, right-hand corner providing Name, Address, Quilt Name, Size, Pattern, and whether it's for sale. If it is for sale, please quote the price.
8. Quilts **not eligible** may be displayed for viewing and/or for sale.
9. Each exhibitor will receive a one-day pass.
10. Judges may award less than first place if there is only one entry in any category and the score does not meet first place requirements.
11. Quilts removed before 9:00 pm on Friday will forfeit any monetary award. Quilts may be picked up Friday night, July 11th, after 9:00 pm.
12. Quilts may also be picked up Monday - Friday, July 14 - 18, at the WVU Extension Office during regular business hours, (8:30 - 4:30) if arrangements have been made at the time of registration.
13. Any complaints as to the judging of the exhibits should be made in writing, to Nicholas County CEOS President, 715 Main Street, Summersville, WV 26651, and should be accompanied by a check for five dollars (\$5.00), payable to NCCEOS. The quilt will be judged again. In the case that the judgment is sustained, the check will be forfeited.
14. CEOS personnel monitor the building every night during the Fair and the building is locked whenever CEOS or Fair personnel are not around, however, the Fair nor the CEOS will not be responsible for loss by theft or damage or any cause whatsoever.
